1. Registration of Interest

2. Registration Requirements

To ensure your registration is complete and valid, the following information must be provided in the form:

- Country of Registration and Registration Number
- o Contact Person's Full Name, Position, Email Address, and Phone Number
- Physical and Postal Address
- Brief Description of Relevant Experience, Core Competencies and Goods & Services to be provided.
- Confirmation of Intent to Participate in the EOI Process
- Declaration of Any Existing Partnerships or Consortia (if applicable)
- Prior Registration on Debswana SAP ARIBA

3. Joint Ventures or Consortia

Where the expression of interest is being submitted by a joint venture or consortium, a single registration form must be submitted on behalf of the group. The form must clearly state:

- The lead partner responsible for communication and coordination
- The nature of the partnership arrangement, including any legal or contractual agreements
